











Resolution of the University of Lleida, by which a competition of merits and skills is announced to formalize an indefinite employment contract under the Scientific-Technical Activities Contract modality, regulated in article 23 bis of Law 17/2022, of September 5, which modifies Law 14/2011, of June 1, on Science, Technology and Innovation. (Ordinary researcher) Call 9/2025 REC.

Given the need to hire a person to carry out tasks related to the research project: N24024 – "CONSOLIDACION INVESTIGADORA. AITOR AMEZTEGUI GONZALEZ" (Ref. CNS2023-145351)

This Rectorate, by virtue of the powers conferred on it by Law 1/2003, of February 19, on universities in Catalonia, the First Collective Agreement of Teaching and Research Staff of Catalan Public Universities, the Statutes of the University of Lleida and the rest of the applicable legislation.

Resolves to convene this competition to formalize the contract whose content appears in Annex 1 of this call.

Against this call, which exhausts the administrative procedure and regardless of its immediate execution, interested parties may optionally file an appeal for reconsideration before the Vice-Rector for Research, within one month from the day after its publication, in accordance with the provisions of article 124 of Law 39/2015, of October 1, on the common administrative procedure of public administrations, or directly file a lawsuit before the Social Court of Lleida within two months from publication.

All the deadlines indicated must be counted from the day after the publication of this agreement on the electronic bulletin board of the University of Lleida (https://tauler.seu.cat).

Similarly, interested parties may file any other appeal they consider appropriate to defend their interests.

ANNEX 1-Call code UdL 9/2025 REC

Type of contract: indefinite employment contract (ordinary researcher).

Number of contracts: 1

Object of the contract: carrying out research tasks within the framework of the LLEGATS project, focused on the analysis of the historical configuration of the landscape and its influence on current forest dynamics.

Tasks to be developed:

- Definition of the structural and morphological characteristics of historical landscapes.
- Quantification of the structure, composition and forest dynamics using multidimensional indicators.
- Evaluation and modelling of the relationship between the configuration of the landscape in the past and the current trajectories of forest dynamics.
- Characterization of the specific diversity and productivity of Spanish forests based on plots of the National Forest Inventory.
- Evaluation of the effects of the history of land use on the provision of different ecosystem services under various climate and management scenarios.

The work to be carried out will primarily consist of carrying out research tasks, aimed at obtaining a high level of professional improvement and specialization by the research staff, which will lead to the consolidation of their professional experience. They will be able to teach.

Basis of the call

1. General provisions

A merit and skills competition is being held to hire a person as an ordinary researcher with an indefinite employment contract according to Art. 23 bis of Law 17/2022, with full-time dedication, with funding for a period from 01/05/2025 to 30/04/2026 (12 months), to develop research tasks related to the research project N24024 – "CONSOLIDACION INVESTIGADORA AITOR AMEZTEGUI GONZALEZ" (Ref. CNS2023-145351).

The contractual modality is a Scientific and Technical Activities Contract, provided for in Art. 23 of Law 17/2022, of 5 September, which modifies Law 14/2011, of 1 June, on Science, Technology and Innovation.

The subject of the contract is listed in Annex 1 of this call

2. Applicant requirements

To take part in this call, applicants must meet the following requirements:

- a) Citizens of any nationality may participate in this call. Non-EU foreign citizens and people who cannot be included in the scope of application of the international treaties concluded by the European Union and ratified by Spain, must have a work and residence permit before the formalization of the corresponding contracts.
- b) Be sixteen years old minimum and not have reached the statutory retirement age.
- c) Not having been separated, due to disciplinary proceedings, from the service of any of the public administrations, nor being disqualified for the exercise of public functions.
- d) Not suffer from any illness or be affected by any physical and/or mental limitation that prevents the normal development of the functions specific to the position.

Specific requirements:

Be in possession of the official doctorate degree or approved for those of an official nature in Spain or recognized in our country, according to current regulations. Degrees with the Haia postil will be accepted.

3. Requests

- 3.1. Those who wish to participate in this selection must submit:
- a) Application form
- b) Photocopy of the DNI, NIE or passport which must be valid at the time of application and throughout the selection process. Applicants will only be required to present the corresponding supporting document in the case













of the passport or, when they have objected to the University's power of verification, in the case of the DNI or NIE, and in the terms provided for in base 8 of this call.

- c) Copy of the doctoral degree. Its submission will not be necessary when the degree is available through mediation platforms between public sector entities and the candidate has not objected to the University's power of verification, in the terms provided for in point 8 of this call.
- d) Curriculum
- e) Applicants, together with the application, must submit photocopies of the documents proving the requirements and merits alleged, and those that are not justified will not be counted.
- f) Declaration document of Absence of Conflict of Interest, duly signed.

The candidate will not have to submit the documents that are already in the possession of the University of Lleida.

- 3.2. Applications must be submitted to the Electronic Register of the University of Lleida.
- 3.3. The deadline for submitting applications will be 20 working days from the day after the publication of this Resolution on the notice board of the University of Lleida's electronic headquarters. The selection process can be consulted by visiting the UdL website:

4. Admission of applicants

- 4.1. Before 5 working days, counting from the end of the deadline for submission of applications, a resolution will be issued approving the provisional list of admitted and excluded applicants, indicating, if applicable, the reasons for exclusion. This resolution will be published on the notice board of the electronic headquarters of the University of Lleida https://seuelectronica.udl.cat/etauler.php
- 4.2. Applicants will have a period of 10 working days, counted from the day after the publication of the provisional list of admitted and excluded, to submit possible claims to correct the defects in the application and the reasons for exclusion.
- 4.3. At the end of the complaints period, a resolution will be issued approving the final list of admitted and excluded, which will be published in the previously established form.
- 4.4. Material and factual errors may be corrected at any time.

5. Selection of applicants

5.1. Members of the selection committee

The candidate's selection proposal will correspond to a committee made up of three members. It will be presided over by the person in charge of the vice-rectorate who is assigned the research or a person to whom she delegates. The other two members of the teaching and research staff (PDI), who must be doctors, and civil













servants or hired from a higher category will be appointed by the corresponding vice-rector from two candidates presented by the project manager.

One of these three will be made up of PDI who are part of the research group to which the project corresponds (if the group does not have enough candidates, the maximum possible number will be proposed). The appointed person will perform the duties of secretary.

The other one will be chosen from a third of PDI, who will not be able to be a member of the research group, mentioned above.

The commission may conduct an interview with the candidates if it deems it necessary.

The commission may appoint an advisor to collaborate in the selection. This adviser will have a voice but not a vote.

5.2. Candidate's proposal

The selection committee will issue a reasoned report that must contain the justification of the score awarded to each applicant, in accordance with the assessment criteria set out in the call, and a proposal for the proposed candidate.

6. Presentation of documents

- 6.1. The Personnel Service of the University of Lleida will contact the selected person and specify the necessary documents that he/she will have to submit in order to formalize the contract.
- 6.2. Those who do not submit the necessary documentation, except in cases of force majeure, which must be duly verified by the convening authority, and those who do not meet the necessary requirements, cannot be hired and their actions will be annulled, without prejudice to the responsibility they may have incurred in the case of falsehood.

7. Duration of the contract

In application of Art. 23 bis, of Law 17/2022, of September 5, which modifies Law 14/2011, of June 1, on Science, Technology and Innovation, this contract will be indefinite.

The initially planned duration of this procurement is linked to the duration of the project's funding for this purpose, which is indicated in Annex 1.

The contract may be terminated for the reasons provided for in article 49 of the revised text of the Workers' Statute Law and development and concordant rules. As well as for objective reasons in accordance with the provisions of article 52, with special mention in its section e) where it is established that in the case of contracts for an indefinite period agreed directly by non-profit entities for the execution of specific public plans and programs, without a stable financial endowment and financed by public administrations through annual budgetary or extra-budgetary appropriations as a result of external income of a finalist nature, due to the insufficiency of the corresponding consignment for the maintenance of the work contract in question.













8. Final rule

In order to notify interested parties of resolutions and administrative acts that affect their rights and interests, the University of Lleida, in accordance with article 45 of Law 39/2015, of 1 October, on public administrations and common administrative procedure, will make the corresponding publications on the board of the UdL's electronic headquarters https://seuelectronica.udl.cat/etauler.php

Against the rules and requirements and conditions of this call, which exhaust the administrative route and regardless of its immediate execution, the interested parties may voluntarily file an appeal for reinstatement before the Vice-Rector for Research, within one month from the day after its publication, according to the provisions of article 124 of Law 39/2015, of October 1, on the common administrative procedure of public administrations or directly before the court of social demand of Lleida within two months of publication.

9. Power of verification of personal data by the University of Lleida

In accordance with the eighth additional provision of Organic Law 3/2018, on data protection and guarantee of digital rights, the University of Lleida remains empowered to carry out the necessary checks to verify the accuracy of the data of the candidates that are essential to submit the application, in the terms required by this call

In accordance with article 28.2 of Law 39/2015, of 1 October, on common administrative procedure, candidates have the right to oppose the exercise of this power of verification, for reasons related to their particular situation. In any case, in the exercise of this right of opposition, the candidate must prove the reasons that justify it, so that they are assessed by the University, and remains obliged to provide the documents to the consultation of which he opposes.

10. Protection of personal data

In accordance with the regulations in force regarding the protection of personal data, please be informed that:

- The person responsible for processing the personal data provided by the candidates, in the present selective procedure, is the University of Lleida UdL- (contact details of the representative: General Secretary. - Candidates' data will be used only for the purposes inherent in this selection procedure.
- The data will be kept at least until the resolution of this selective procedure becomes final, due to the expiry of the deadlines for challenging it without any interested party having lodged an appeal against it, and will be destroyed in the terms and conditions provided for in the regulations on the conservation and disposal of administrative documents of the UdL, and the document evaluation tables approved by the Generalitat of Catalonia (http://www.udl.cat/ca/serveis/arxiu/)
- The data provided are mandatory to exercise the organizational powers of the UdL inherent in university autonomy, within the framework of article 27.10 of the Constitution; of Organic Law 6/2001, of December 21,













on universities; of the Statutes of the University of Lleida, and of the legislation on civil service and the legal regime of the public sector.

- The UdL will not transfer or communicate the data to third parties, except in the cases strictly provided for in the Law.
- Candidates can access their data; request its rectification, deletion or portability; object to the treatment and request its limitation, as long as it is compatible with the condition of a candidate in the present selective procedure, by means of a letter sent to the address dpd@udl.cat.
