

Resolution of the University of Lleida to formalize a fixed-term employment contract under the category of Research Staff in Training (Personal Investigador en Formació), in accordance with Royal Decree 103/2019 of 1 March, which approves the Statute of Pre-doctoral Research Staff in Training. Call 10/2026 REC.

On April 27, 2026, the University of Lleida published a call for a merits- and abilities-based selection process to formalize a fixed-term employment contract under the category of Research Staff in Training (Personal Investigador en Formació), in accordance with Royal Decree 103/2019 of 1 March, which approves the Statute of Pre-doctoral Research Staff in Training, to carry out research tasks funded by project G25003 RESTORATIVE (Project: 101227219 — RESTORATIVE — HORIZON-MSCA-2024-DN-01).

On July 2, 2026, the final list of admitted and excluded applicants from the competition was published on the notice board of the electronic site of the University of Lleida.

On July 8, the list of candidates who had passed Phase 1 of the competition was published; on July 13, the list of candidates who had passed Phase 2 was published; and on July 24, the list of candidates who had passed Phase 3 was published.

Against this resolution, which exhausts the administrative procedure, and notwithstanding its immediate enforceability, an optional appeal for reconsideration may be lodged, prior to judicial-administrative proceedings, before the same body that issued the resolution, within one month from the day following its publication on the notice board of the Electronic Office of the University of Lleida (<https://tauler.seu.cat>), in accordance with Articles 123 and 124 of Law 39/2015 of 1 October, on the Common Administrative Procedure of Public Administrations. Alternatively, a claim may be filed directly before the Labour Court of Lleida within two months from the date of publication.

Likewise, interested parties may lodge any other appeal they deem appropriate in defence of their interests.
